#### **COURSE PREREQUISITES:**

None. Course approved for General Education literature requirement.

#### COURSE DESCRIPTION:

A specialized topics course on Caribbean society and literary expression, featuring analysis of literature and other areas such as film, history, music, politics, performance, religion, or popular culture. Topics vary per semester. Course can be taken up to three times when different themes are covered.

This semester's course will focus on the role of the beach within Caribbean literature. Special attention will be given to the ways in which the beach is portrayed and thus re-presented in the text(s) as a means of re-writing the nation-making narrative of the region in order to question, contest, re-write, re-shape, re-view and thus, re-present the Caribbean, its cultures, its peoples and ultimately, its identity[ies].

### **COURSE OBJECTIVES:**

Students will be able to:

1. Demonstrate basic knowledge of the origins of the Caribbean in connection to its history of violence, fragmentation, and erasure in conjunction with its alternative histories.

2. Read critically and utilize research resources relevant to the study of the trope of the beach in the Caribbean.

3. Gain understanding of the historical or cultural contexts significant to the study of Caribbean literature.

4. Gain knowledge of the various manifestations, purposes, and symbolisms of the beach as well as contributing new scholarship to the field.

5. Write weekly critically informed responses to the readings, write/present literary critical essays/presentations that interpret the selected texts with a focus on the topic of the beach in the Caribbean.

6. Gain understanding of the essential role of language in both literary and nonliterary contexts in connection to the topic under study.

### Rules of the Game:

Students are required to complete a series of weekly response papers that count for 100 points of the course grade (10 points each). These will take the form of an MLA-style, one page, double-spaced, size 12 font Times New Roman wordprocessed document to be handed in during class. There will be no make-ups for this course requirement. However, a one-time make-up opportunity will arise during the semester. Therefore, students' presence in class is a determining factor for the course grade. Since the response papers will be handed-in on a weekly basis, completing the assigned readings prior to class is of the utmost importance. Not complying with this minimum requirement will result in course failure and/or cancellation.

There will be three main assignments during the semester. 1). Students are expected to divide in groups (depending on class size) and present on one of the texts pertaining to the course reading load (100 points of course grade); 2). Prepare one short (6-8 page) midterm paper (100 points of course grade); 3). Write one substantial (8-10 page) final paper (100 points of course grade).

All written assignments must follow MLA format and must be handed in at the allotted time at the beginning of class or as otherwise specified. For the latest MLA Eighth edition, go to: <u>http://owl.english.purdue.edu/owl</u> or <u>http://mla.org/style</u>. Papers must be printed out; I will not accept papers sent via email.

\*The other supplementary texts will also be sent as links via email and require no reading in advance. Some of these texts, if not all, are available in the English Department's Richardson Seminar Room.

Since courses are based on contact time, class attendance is compulsory at this university. All professors throughout the course of the semester submit attendance reports. If a student is often absent, he or she is liable to not receiving the Federal Aid check. In addition, attendance will be numerically surveyed through the response papers. If absent (without the formal documentation) more than once, the student is liable to course failure. Attendance will be taken at the beginning of every class. If you are more than twenty minutes late, please refrain from entering the classroom. Otherwise, please remind me at the end of class to remove your presumed absence.
