Grammar of Modern English: Sentence and Clause Structure

I. Course Description

INGL 4206 is a course for students who are proficient in English and who have taken one of the following: INGL 3103, 3104 or INGL IMGL 3011-3012 or at Level 5 on the HEPT or have advanced placement in English.

English course catalog description: Syntactic analysis of constituent structure of English, proceeding from the simple sentence to the complex, including the noun phrase, adjective clause, noun clause, gerund and infinitive phrases, and compound structures. **This course is offered face-to-face, online and hybrid.**

Additional information: This course is designed for those students who are interested in understanding the syntactic structure of Modern English for analysis, criticism and/or composition. The methods presented are not integral to any one theoretical model but will provide students with information about and experience in analyzing, parsing, and composing grammatical constituents in English. The course is designed so that students will take control of and responsibility for their own learning needs and outcomes. This is not a lecture course; students will dedicate time to reading and learning content outside class time and completing exercises both in class and as assigned homework with structured guidance from the professor. Classes will be interactive and students will be given ample opportunity to work individually and to participate in small group work and whole class problem solving activities.

II. Course Objectives:

At the conclusion of the course, students will be able to:

- a. identify different grammatical constituents;
- b. use tools of syntactic analysis such as word class categories and tree diagrams;
- c. differentiate the main constituents of phrases, clauses and sentences;
- d. classify the typology of English verbs;
- e. reduce grammatical constituents embedded in larger structures
- f. contribute in an effective manner to the inclusion of fellow students with special needs in the classroom and group work

III. Teaching Strategies / Methodology

Students will be assigned study material related to specific syntactic concepts that are required reading before class. Then, classes will consist of a (brief) review and discussion session of the required reading in addition to parsing and composition exercises that may be completed individually, in pairs, small groups, or as a whole class. After covering the material in class, there will be assigned work to practice and evidence learning.

Important note: In the course outline above, details regarding *the dates* for all class activities have not been included, as this information is always subject to change. Please keep in mind that each class meeting corresponds to *1.5 credit hours*; a full week of class corresponds to *3 credit hours*. Thus, we obtain the required 45 credit hours throughout the semester.

V. Course Requirements and Evaluation

1. Attendance: Students are expected to attend class each day and also arrive on time. Students will receive a **100 point** attendance grade at the end of the semester. Each unexcused absence to any class signifies a reduction of seven (7) points for this aspect of each student's performance.

Students have made a personal commitment to all of their college courses and, therefore, can fully benefit from them only by attending each day. Only serious illness, the loss of a family member or other extremely serious circumstances will be considered as a valid excuse for absences. Punctuality is also very important. Students must be **present** for each test / presentation. Only a very **serious** emergency will be accepted in the case of a makeup exam. If not, a grade of <u>0</u> will be given. Attendance as well and punctuality are **mandatory**. A close record of each student's attendance at all online sessions will be kept. Make-up tests, given only under these circumstances, will be somewhat different from those taken by the group. Naturally, under the current circumstances due to online classes and given the pandemic, a good deal of flexibility and understanding is demonstrated in light of WIFI / Internet / electrical power issues with which we now all have to deal.

- 2. There will be numerous individual and / or group oral presentation (25 pts.) based upon a variety of topics which arise during the course of the semester.
- 3. There will be **two written exams** during the course of the semester. Please note that both exams will be held asynchronically following the discussion of Chapters 1-4 and Chapters 5-8, respectively. (Please see course outline above).
- 4. A full (100 pt.) grade based on each student's class participation, daily performance, and effort will be given at the conclusion of the semester.
- 5. Students are asked to always have the following materials for each class session: their textbooks, any assigned work ready and a notebook.
