Objectives: English 3252 offers a survey of American literature from the mid-nineteenth century up to the present through analysis of a variety of texts: essays, poems, fiction.

Attendance: You will be allowed 5 absences without repercussions. Each absence over the 5 costs you 1/3 of a letter grade. I do not differentiate between excused and unexcused absences, so use your 5 wisely. Keep in mind that you are still responsible for the work on days you miss.

Participation: Class time will be devoted to DISCUSSION, not just lecture, which means you must participate. Participation comprises 5% of your grade.

Journals: You will create a Google Drive online folder where every week you will upload no more than 2 paragraphs for each author covered until that date. These are NOT formal essays. Rather, they should demonstrate reading comprehension by analysis of a specific detail, instance, quote, or character from the reading. They are to be based SOLELY on your critical thinking skills and class discussions, not on any outside sources.

Exams: There will be 3 exams (dates on schedule). Exams will consist of short answer questions and a choice of essay questions. Each will be worth 25% of your final grade, and will be uploaded to your Main Folder. Quality exams will demonstrate critical thought, not just memorization.
