- e. Enumerate information concerning the principles of nonverbal messaging: its ubiquity, variety of functions, spread of use, impact on the making of meaning, primacy, ambiguity, and acceptance
- f. Differentiate between digital and analog representations
- g. Explain the processing of the message and role of cultural variation; compare US/PR systems
- h. Discuss the role of identity in the nonverbal codes of communication
- i. Provide an explanation of the systems of nonverbal communication, their displays, variety of meanings, and the connections they send to verbal communication
- j. Describe the various ways in which we can apply nonverbal principles across contexts as, for example, in technology and social media, professional contexts and interpersonal relationships
