English 3252: American Literature from 1865 through the Present

Course Description: This course provides a survey of key texts, authors, and topics that help define the dominant tendencies found in, and the continued development of, US literature after that nation's Civil War and into the present. Through an assortment of short stories, novels, essays, and poems, we will explore the changing ideological landscape through a variety of periods, including the Reconstruction era (Realism and Naturalism), the interwar period (Modernism), and the post-WWII period (Postmodernism). The texts selected – some canonical, others not quite – will offer us the chance to meditate on the tensions that characterize each respective period while also giving us the opportunity to analyze contemporary events. Topics will include race, gender, class, nation, citizenship, civil rights, colonialism, mental health, disabilities, and identity. Similarly we also will consider formal choices and their effects on reception and accessibility.

Objectives: Students will gain a better understanding of US literature from 1865 onwards, its periods, tendencies, and key figures. They will also further develop their reading, writing, and analytical skills.

Requirements: Works required include:

- Two-page paper. Due Feb 21st. (10%)
- Four-page midterm paper. Due March 14th. (20%)
- Six-page final paper. Due date to be determined. (30%)
- All papers will be graded based on: thesis clarity; writing soundness and effectiveness; convincing analysis; and creativity/originality of thought.
- Participation and quizzes. (40%)
 - As part of the participation component, each student will be asked to help lead discussion once during the semester. A list will be handed out for discussion selection early in the semester.
- **Texts**: The Norton Anthology of American Literature: 1865 to the Present, 10th or 9th Edition. Ed. Robert S. Levine.

- Fun Home: A Family Tragicomic by Alison Bechdel.
